# **Data processing**

For policy and claims management handling, personal data may be transmitted to our insurer, Baloise Insurance, and DEKRA Belgium nv, which manages claims on behalf of Baloise Belgium. ## Obligations in case of material damage

- ▶ Please submit your claim to ALD Automotive / Axus using the declaration form attached no later than 8 days after having noticed the damage.
- > Should there be a party liable for the damages, their contact data must be submitted immediately.
- ➤ The declaration form must always include:
  - a photo of the complete bicycle
  - a photo of the bicycle frame number (clearly legible);
  - at least one photo that clearly shows the damage to the bicycle.

In all cases, a repair agreement must be concluded before any damage is repaired. The invoice is to be listed under Axus NV (BE 0403 429 730).

### **Obligations in case of theft**

- ▶ Theft must be reported to the police within 24 hours of discovery with a request to include the bicycle's unique frame number on the official report.
- ▷ Claims must be reported to ALD Automotive / Axus no later than 8 days after having noticed the theft by submitting the following:
  - the completed declaration form;
  - the original police report affidavit;
  - all original keys of the ART-approved safety lock.

A claim must be filed even if the lock keys are the only items that have been stolen or lost. Please have the lock and keys replaced as soon as possible to prevent any theft of the insured vehicle.

### **General obligations**

- Make sure to take all steps required to prevent and limit the damage.
- ▶ Make sure to provide any information requested in relation to the damage or theft.
